
### Sage Grouse: The Spotted Owl on Steroids - Will Impact 11 Western States

- ➤ Greater Sage-Grouse ("GSG") is a "landscape species"
  - Over 100 million acres GSG habitat in western US
  - BLM lands contain over 50% of GSG habitat
- ➤ USFWS made GSG a candidate species in 2010
  - "Inadequate regulatory mechanisms" to conserve habitat
- NV has the most GSG habitat (20 million acres)
- > WY has the most birds

# Two Perilous Paths to Sweeping Land Use Restrictions Throughout Western US

BLM/USFS 2015 Land Use Plans	USFWS 9/2015 Listing Decision

Worst (and most likely) outcome:
BLM imposes drastic land use restrictions to prevent a listing
USFWS determines listing is warranted anyway

## Senator Gardner's Sage Grouse Protection & Conservation Act



- Creates implementation and monitoring period for Stateled conservation plans
  - States developing plans in response to 2011 invitation from then DOI Secretary Ken Salazar that state plans could avoid the need to list the bird
- ➤ Gives states enough time (at least 6 years) to prove plans can protect sage grouse and conserve its habitat
- ➤ Requires DOI Secretary to defer to state conservation plans and to maintain GSG as candidate species
  - Overrides arbitrary 2015 listing deadline in NGO settlement
- States must provide annual progress report to DOI
- Prohibits DOI from imposing widespread withdrawals

## 3 Parallel GSG Strategies

#### Work with Congress - Legislative Strategy

Gardner Sage Grouse Protection & Conservation Act
Give state conservation plans time to work so listing not needed
Funding restrictions in Appropriations bills (FY 2015 and future years)
Prohibits DOI from implementing a rule to list the bird as T or E

#### Participate in EIS Process - Administrative Strategy

Extensive comments on Draft and Final Land Use Plan Amendments/EIS WMC submitted comments on draft LUPAs/EIS WMC will comment on final documents

### **Seek Court Intervention - Litigation**

NV & OK lawsuits in federal district courts challenge the NGO settlements

American Exploration & Mining Assoc. is a co-plaintiff in NV case Estoppel claim in NV lawsuit

DOI must honor Secretary Salazar's invitation to States to develop conservation plans and give plans time to work

Data Quality Act lawsuit (AEMA is a co-plaintiff)

Future litigation to challenge final LUPAs and EIS documents
